NOTES

- 1 To be valid this form of proxy must be received at the SOA Registered Office (National Orienteering Centre, Glenmore Lodge, Aviemore, PH22 1QU) not less than 48 hours before the time of the meeting (please note that postal deliveries to Glenmore Lodge can take a day longer than is the norm in cities and arrive late in the day).

Voting eligibility as given in the BYE-LAWS OF SCOTTISH ORIENTEERING ASSOCIATION available on the SOA website and modified to bring them in line with the Companies Act 2006

The voting rights are

(i) as defined in the Memorandum and Articles

- Individual Members shall each have one vote,
- Youth members shall have no voting rights,
- Families shall have one vote for each member of the family over the age of sixteen,
- Honorary members shall have no voting rights, and

(ii) as specified in this Bye-law

- Groups are allowed up to two votes. However the number of votes cannot be greater than the number of members of the group who are over the age of sixteen years.
- Clubs shall have no voting rights.
